Notwithstanding anything to the contrary herein, Vanderbilt Community Association, Inc., reserves the right, from time to time, in its sole and absolute discretion, to reserve memberships for future purchasers of its property, to terminate memberships, to restrict or reserve use of the Club from time to time, to sell or otherwise dispose of the club in any manner whatsoever and to any person whomsoever, and to make any other changes in the terms and conditions of membership, or the Club, available for use by members. A Member only acquires a revocable license to use the Club.

I hereby acknowledge that the use of the Club facilities and any privilege or service incident to membership in the Club is voluntary and that the use and acceptance of any service or privilege incident to membership is undertaken with acknowledge of risk of possible injury. I hereby accept any and all risk of injury to myself, my guests and family members sustained while using the Club facilities or involved in any event or activity incident to membership in the Club.
